## Application Guideline

### For Master's Degrees

#### 1. Purpose

The KOICA Scholarship Program (SP) for master's degrees is designed to nurture key leaders in developing countries who can contribute to the socio-economic development of their home countries.

#### 2. Target Countries

- Countries selected by KOICA among the DAC List of ODA Recipients
- The list of target countries is subject to change annually to the policies of the Korean government or KOICA

### 4. Qualifications

Prospective applicants must meet all of the following conditions.

- (1) **Citizenship:** Be a citizen of the Scholarship Program target country.
- (2) **Government Nomination:** Be officially nominated by their governments.
  - Be a government employee. With a minimum of 2 years of experience in the field of study
  - \* Exception - Applicants with an 'international development NGO' background may apply for the program with two letter of recommendations:
    - Your government office; and
    - Korean Embassy, world widely known NGO, an UN-associated organizations, or the KOICA Organization within your region.
- (3) **AGE:** (Preferable) be under age 40 as of February 1, 2019.
- (4) **Health:** Be in good health, both physically and mentally.
  - Those with disabilities, but in good mental and physical health, are eligible to apply.
  - Those with severe illness are NOT ELIGIBLE to apply.
- (5) **Level of Education:** Have a completed Bachelor Degree or an equivalent to college / university level Educational background.
  - \* Some program have specific qualifications in terms of level of education, and refer to Program Information of each program.
- (6) **English Proficiency:** Have a good command of both spoken and written English in order to take classes conducted entirely in English and to be able to write academic reports and theses in English.
- (7) Not be a person who has withdrawn from KOICA's scholarship program.
  - \* Person belonging to the institution in which candidates submitted false documents and returned to his / her country arbitrarily in the middle of SP program cannot apply.
- (8) Have not participated in KOICA's scholarship program or any of the Korean Government's Scholarship Program before (Master's degree program).

<b>Air Fare</b>	Actual amount paid	<ul style="list-style-type: none"> <li>- Cannot be borne by KOICA in special circumstances like when a participant violates academic regulations</li> <li>- Not borne by KOICA when a participant Temporarily leave to his/her home country during the training period</li> <li>- Except for above, borne by KOICA</li> </ul>
<b>Tuition Fees</b>	Full amount required by a university	<ul style="list-style-type: none"> <li>- Borne by a training institute</li> </ul>
<b>Extracurricular Activities</b>	Part of the expenses needed for study visits, workshops, Korean language classes and others, except for regular classes	<ul style="list-style-type: none"> <li>- Amount borne by a school varies</li> <li>- Part of the expenses can be borne by participants, and the amount varies among training institutes</li> </ul>
<b>Monthly Allowance</b>	KRW 999,000 per month	<ul style="list-style-type: none"> <li>- It includes expenses for meals, books and study supplies if needed</li> <li>- Same amount will be provided per month</li> <li>- If a participant cannot participate in the course for specific reasons like temporary leave to his/her home country, the allowance for that month shall be prorated for the corresponding number of days studies in Korea (KRW 33,300/day).</li> <li>* The amount deducted (33,300/day) is the same regardless of how many days are in the month.</li> </ul>
<b>Accommodation</b>	Actual amount paid	<ul style="list-style-type: none"> <li>- Electricity and other utility fees shall not be covered.</li> <li>- Cost for cleaning, laundry or exchange of bedding shall not be covered.</li> <li>- Except for above, borne by a training institute</li> </ul>
<b>Settlement Allowance</b>	KRW 600,000	<ul style="list-style-type: none"> <li>- Expenses needed to enter Korea, such as visa fee, alien registration card issuing fee and others</li> <li>- Borne by a training institute</li> </ul>
<b>Scholarship Completion Grants</b>	KRW 300,000	<ul style="list-style-type: none"> <li>- EMS and other expenses needed for returning home (e.g. cost for sending materials)</li> <li>- Borne by a training institutes before departure</li> </ul>
<b>Insurance</b>	Actual cost paid	<ul style="list-style-type: none"> <li>- Expenses for insurance contracts during stay in Korea</li> <li>- Borne by KOICA</li> </ul>

\* Notes

- KOICA arranges and pays for the participant to travel to and from Korea. KOICA will cover economy class, round-trip airfare.
- If a participant wants to change the flight itineraries, they should pay the additional airfare.
- The participant is responsible for the issuance of an appropriate visa (which must be the 'Study Abroad Visa [D-2]) necessary for this Scholarship Program.

April 23, 2019	<b>Application</b>	<p><b>[Application package submission]</b></p> <ul style="list-style-type: none"> <li>- <b>Application deadline (to KOICA regional offices and Korean Embassy) : April 23, 2019</b></li> <li>- Prepare all required documents for your admission package and fill out the 'Document Checklist'.</li> <li>- Submit the application package (including both university and KOICA application forms and other required documents) to KOICA regional office or Korean Embassy by the submission date.</li> </ul>
April 24-29	<b>On-site Interview(KOICA)</b>	- Participate in an on-site interview by KOICA regional office or Korean Embassy. If an applicant lives in a country where the KOICA regional office / Embassy does not exist or lives far from the capital city, he / she can be interviewed by phone after consulting with the KOICA regional office / Embassy.
May 1 -May 8	<b>Document Screening</b>	<p><b>[1<sup>st</sup> round : Document Screening]</b></p> <ul style="list-style-type: none"> <li>-Applicants nominated by the KOICA regional office or Korean Embassy as a result of the on-site interview and have submitted their application packages are considered for document screening.</li> <li>-University conducts document screening,</li> </ul>
May 10	<b>Result of Document Screening</b>	<ul style="list-style-type: none"> <li>-The result for the 1<sup>st</sup> round selection will be announced to the applicants.</li> </ul> <p><b>[Preparation for the 2<sup>nd</sup> round]</b></p> <ul style="list-style-type: none"> <li>- Details of the interview including the interviewee list will be sent to the KOICA regional offices and interview arrangements will be made respectively.</li> </ul>
May 13 -May 24	<b>Interview</b>	<p><b>[2<sup>nd</sup> round : Phone Interview]</b></p> <ul style="list-style-type: none"> <li>- University conducts the second round (interview) according to the interview schedule.</li> <li>- Schedule for phone interview will be notified individually by the KOICA regional offices or Korean embassy with 2-3 day notice in advance.</li> <li>- KOICA HQs announces the result of interview to the KOICA regional office or Korean Embassy : May 28</li> </ul>
May 29 -June 21	<b>Medical Checkup (Local)</b>	<p><b>[3<sup>rd</sup> round : Medical Check-up]</b></p> <ul style="list-style-type: none"> <li>- Applicants who successfully pass the 2<sup>nd</sup> round must take the Medical Check-up at the designated institution.</li> </ul>

		<ul style="list-style-type: none"> <li>-The detailed guideline of the medical check-up and list of the designated medical institution will be notified after passing the interview successfully.</li> <li>- Examination cost, Transportation and accommodation fees will NOT be reimbursed.</li> <li>- KOICA will not pay for the treatment necessary after the examination.</li> <li>- KOICA announces the result of Medical Checkup.</li> </ul>
June 26	<b>Admission Notification</b>	<ul style="list-style-type: none"> <li>- Admissions results will be notified to the regional KOICA offices or Korean embassy.</li> <li>- KOICA informs the participants of their scheduled entry to Korea.</li> </ul>
August	<b>Entry to Korea</b>	
	<b>Medical Checkup (In Korea)</b>	<p><b>[4<sup>th</sup> round : Medical Check-up]</b></p> <ul style="list-style-type: none"> <li>- Applicants who successfully entering to Korea must take the Medical Check-up again at the designated medical institution.in Korea</li> <li>- Examination cost will be provided by KOICA.</li> <li>- <b>If the participants are disqualified for long-term stay by the medical checkup in Korea, the participants may have to return to their home country.</b></li> <li>- KOICA announces the result of Medical Checkup and will share it with participants to support their own health care.</li> <li>- KOICA will not pay for the treatment necessary after the examination.</li> </ul>

### \* Important Notes for All Applicants:

- All forms should be typed in English and all the supporting documents should be in English. Documents in any other language should be accompanied by a notarized English translation.
- Original documents should be submitted. (If it is unavailable, the originating institution must authorize copies before they are submitted.)
- If any of the submitted materials contain false information, admission will be rescinded.
- Applicants whose forms and supporting documents are incomplete or unsatisfactory will be disqualified from the admission process.
- Applicants should take full responsibility for any disadvantage due to the mistakes or

omissions on the application.
